## OBSTETRIC AND GYNAECOLOGICAL EXPERIENCE

## Clinical, Research & Managerial Experience

It was during my placement on the Oxford Vocational Training Scheme that I first decided to pursue a career in Obstetrics and Gynaecology. Over a three-year period, I was fortunate to gain experience in a diverse range of obstetric and gynaecological conditions and was also able to appreciate management of these conditions in a variety of clinical settings.

At Frenchay and Southmead Hospitals, Bristol, and at the Norfolk and Norwich Hospital, Norwich, I welcomed the opportunity to gain a broad clinical training within busy units. Whilst at the Norfolk and Norwich Hospital, I managed an early pregnancy assessment unit where I gained competence in the use of transvaginal ultrasound. Regular attendance at a pre-natal diagnosis clinic also gave me valuable experience in the use of transabdominal ultrasound. At both centres, I was able to develop my gynaecological experience and acquire new surgical skills. In particular, I gained experience in colposcopy, urodynamics and in limited therapeutic laparoscopic techniques.

At Addenbrooke's Hospital, Cambridge, I had the opportunity to consolidate my clinical experience and to further develop my surgical skills. I was actively involved in a prenatal diagnosis clinic on a weekly basis. This gave me an opportunity to improve my skills in the use of obstetric ultrasound and develop an interest in materno-fetal medicine.

At Queen Charlotte's, I performed research into monochorionic twins funded by the Richard and Jack Wiseman Trust and SPARKS (Sport aiding research into kids). In particular, I completed a PhD thesis entitled: "Haemodynamic causes and consequences of twin-twin transfusion syndrome" for the University of London (Imperial College, 2003). This research demanded a high standard of ultrasound. In addition, I was responsible for the care of all monochorionic gestations at Queen Charlotte's and ran a weekly scanning clinic. I became familiar with the use of colour Doppler in the assessment of fetal wellbeing and also in the detailed techniques of placental mapping. I also contributed to the general running of a fetal medicine unit, being exposed to a wide

range of fetal conditions and enjoyed obtaining the skills necessary to the discipline of fetal medicine which include antenatal diagnosis, invasive testing and fetal therapy. During my research I maintained my general obstetric and gynaecological skills by working as senior registrar on the on-call rota at the Hammersmith Hospital and also by performing several consultant locums at the St Helier Hospital, Jersey.

I completed my general training in obstetrics and gynaecology at Queen Charlotte's as a year 5 specialist registrar before becoming a subspecialist trainee in Fetal and Maternal Medicine on the Centre for Fetal Care. During this post I was exposed to the full range of high risk maternal and fetal problems and developed diagnostic and therapeutic skills to become enrolled on the subspecialist registry. In addition, I had experience in endoscopic laser techniques in the management of complicated monochorionic twins and became able to offer the full range of available treatments for such pregnancies.

I am enjoying my position as Consultant in Obstetrics and Gynaecology at the Royal Devon and Exeter NHS Foundation Trust which began in August 2003. I continue to develop my interest in fetal medicine whilst also maintaining a general obstetric and gynaecological practice.

In fetal medicine, I was pleased to introduce an NHS first trimester clinic which achieved national recognition by the National Screening Committee by becoming a "Centre of Excellence" - the first unit to be given this status in the UK. The screening clinic team was also pleased to reach the National Finals of the 2006-7 NHS Live Awards. I also helped introduce a telemedicine link to the fetal medicine department. Complex cardiac fetal conditions are regularly diagnosed and monitored "over the wire" with a perinatal cardiologist at the Bristol Royal Infirmary. In 2013, I helped establish and chair the Peninsula Fetal Medicine Network. In 2014, our department hosted the regional fetal medicine meeting in Exeter in 2014 – the first time that this meeting was held outside Bristol since its inception in the late 1990's. For mothers, we offer non-invasive Rhesus genotyping on the NHS and, in 2021 extended our service to offer this test to mothers whose combined screening shows a high chance of T13/T18/T21. In 2020, with a colleague in Bristol, I began co-leading the new Southwest Fetal Medicine Network.

I also aim to offer a high quality urogynaecological service. Before the NHS "pause" on the use of vaginal mesh, an audit of the TVT operation for urinary incontinence of my own patients showed a 92% success rate - an improvement over many of the results reported in the literature. Audited results of my vaginal Z-plasty procedures (to release vaginal scarring causing pain on intercourse) showed 82% of women had definite improvement in pain scores. I have also introduced a modified method of sacrospinous colpofixation operation for patients with severe vaginal vault prolapse. Insertion of sutures under direct vision is considered by some to be safer. In response to the pause on the use of TVT, I have helped re-introduce abdominal colposuspension, and introduced a new technique to our department of periurethal injections (Bulkamid) as surgical options for the treatment of urinary incontinence.

The amount and quality of audit/ research continues to increase in our subdirectorate. I am pleased to have played a major part in promoting this increased activity. As an honorary senior clinical research fellow at the Exeter Medical School, I enjoy pursuing my research interests. Projects have included the development of 3D

ultrasound, particularly in the first trimester, the introduction of portable hand-held Obstetric ultrasound machines to be used in the community by midwives, the use of patient education videos prior to Caesarean section, the use of a new package of measures to assess intra-operative blood loss at Caesarean section, and the development of "Guidelite" - an app for use on smart phones on which summary Trust guidelines can be viewed. The latter, although not adopted, did pave the way for the introduction of a similar app which is used in both Exeter and North Devon.

I have been the clinical audit lead in our sub-directorate for over 15 years and was Chair of the Clinical Audit and Guidelines Group in the Trust until this was suspended in 2020 on account of the COVID-19 pandemic. Nevertheless, I relish the opportunity to promote quality audit projects as they can produce significant improvements in patient care. In addition, I helped set up the Gynaecology Governance Group which I chaired for almost 4 years. This helps monitor and reduce risk in daily gynaecology practice.

As medical lead for the productive ward initiative, I introduced the use of VitalPac to Wynard Ward in 2010. VitalPac allowed the electronic acquisition and storage of patient observations using hand-held devices. Its introduction was audited and found to be associated with a significant increase in the standard of observations and also in the reliability of, and appropriate clinical response to, a deteriorating patient.

In 2017 I completed being secondary care consultant on the board of the Bath and North East Somerset (BANES) Clinic Commissioning Group (CCG). This involved regular meetings to help provide advice to the CCG on secondary care issues. I found this experience very interesting and look forward to expanding this type of role in future.

In 2018 I was elected President of the British Maternal & Fetal Medicine Society (<a href="https://www.bmfms.org.uk">https://www.bmfms.org.uk</a>). This was a challenging role which I enjoyed greatly. I had my first meeting of my Presidency in Edinburgh in March 2019 which received very positive feedback.

In 2019-2020 preparations were well under way for a combined BMFMS/BPAM/NNS meeting in London (June 8-10). However, owing to the coronavirus pandemic, we had to cancel this meeting. This process was extremely demanding as the BMFMS stood to lose large sums of money. I aimed to keep such losses to a minimum to ensure that the society could survive.

In 2020-2021, my role was one of trying to maintain the viability of this, the largest Obstetric society in the British Isles, in the face of huge challenges due to the pandemic. We re-established conferences and courses – all online. I am confident that the BMFMS has not only survived but remains in a strong position to face whatever challenges the future may bring it when things return to the "new normal".

I have an active Medico-Legal practice providing expert opinion on Obstetric, Fetal Medicine and Gynaecological cases to claimants, defendants, the GMC, coroners inquests, and also my own Trust. This direct experience of the legal aspects of my specialty complements my role as a senior clinician in our department, particularly when governance, risk management, or consent issues arise. My legal work has also

resulted in being an invited speaker at a number of conferences to help educate Obstetricians on medico-legal topics and how to avoid litigation. (https://www.mylestaylor.co.uk/)
